### **Collection of Information**

In order to use the Eastern Dandenong Ranges Association Inc websites [dandenongandranges.com.au](http://dandenongandranges.com.au), [edra.org.au](http://edra.org.au) and [thelocal.org.au](http://thelocal.org.au) we may require information from you in order to provide the best service possible.

All correspondence may also be collected and stored, particularly in regard to sales, support and accounts, including Email.

Any information collected by Eastern Dandenong Ranges Association Inc including its subcommittees Eastern Dandenong Ranges Business & Tourism and The Local Newspaper for the Eastern Dandenong Ranges is collected via correspondence from you or your company. This may be via the telephone, email, mail, fax or directly through our websites.

### **Use of Collection Information**

Any details collected from Eastern Dandenong Ranges Association Inc customers is required in order to provide you with our products and/or services, and a high level of customer service.

Correspondence is recorded in order to provide service references.

### **Storage of Collected Information**

The security of your personal information is important to us. When you enter sensitive information (such as credit card numbers) on our website, we encrypt that information using secure socket layer technology (SSL).

When Credit Card details are collected, we simply pass them on in order to be processed as required. We never permanently store complete Credit Card details.

We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it.

## **Eastern Dandenong Ranges Association Inc Security Policy**

Eastern Dandenong Ranges Association Inc uses the eWAY Payment Gateway for its online credit card transactions. eWAY processes online credit card transactions for thousands of New Zealand merchants, providing a safe and secure means of collecting payments via the Internet. All online credit card transactions performed on this site using the eWAY gateway are secured payments.

- Payments are fully automated with an immediate response.
- Your complete credit card number cannot be viewed by Eastern Dandenong Ranges Association Inc or any outside party.
- All transactions are performed under 128 Bit SSL Certificate.
- All transaction data is encrypted for storage within eWAY's bank-grade data centre, further protecting your credit card data.
- eWAY at no time touches your funds; all monies are directly transferred from your credit card to the merchant account held by Eastern Dandenong Ranges Association Inc.
